About The Ottawa Farmers' Market:

The Ottawa Farmers' Market (OFM) is a producer-only, non-profit association of 150+ vendors from the Ottawa region. Providing an opportunity to buy the freshest local products directly from the people who produce them, the Market is also a great place to meet friends, have lunch, enjoy live music, and build community.

Our mission is to lead vibrant farmers' markets where local farmers, makers, bakers, and food entrepreneurs can flourish by delivering premium self-produced goods to community members across Ottawa. OFM vendors are located within 100 km of Ottawa, and a minimum of 51% of our vendors are agricultural producers as defined by a true farmers' market.

The OFM has five Outdoor Farmers' Market locations (Lansdowne, Main, Westboro, Orléans, & Barrhaven). This job posting is for the **Lansdowne Farmers' Market**, which has 75+ vendors.

Position Overview:

Position Title: Lansdowne Market Supervisor

Position Type: Seasonal, Part Time

Location: Aberdeen Square (1000 Exhibition Way, Ottawa, ON K1S 3W7)

Dates: Every Sunday from May 5 - October 27, 2024

Hours: Approx. 9 hours per week, from 7am-4pm on Sundays only

Transportation: Transportation to and from the Market site is the responsibility of the Market Supervisor. Arrival no later than 7am is mandatory.

Compensation: \$21.95 per hour. The OFM is a living wage employer.

Position Summary:

The OFM is seeking a Market Supervisor to work at the Lansdowne Market every Sunday, 7am-4pm during the Outdoor Farmers' Market Season. Alongside the Operations Manager, the Market Supervisor will complete onsite duties including setup / teardown and running the Market Info Booth. They will also share responsibility for overseeing the Market site, vendors, volunteers, and programming.

This position is onsite only. The Operations Manager will provide onsite training and support for the first few Market dates. A Manager will always be onsite with the Market Supervisor and reachable by phone or walkie talkie, given the larger scale of this Market location.

The ideal candidate is organized, self-motivated, approachable, and passionate about our local food community.



Key Responsibilities:

1. Market Setup / Teardown:

Chalk out vendor stalls; put out and pack up infrastructure including up to four weighted tents and heavy picnic tables; set up Info Booth; put out signage; and clean up site and infrastructure as necessary.

2. Info Booth:

Create an engaging and welcoming environment for all market goers; answer customer questions; administer First Aid; count customers; complete Daily Data Sheet for the Operations Manager; run occasional prize draws; and complete occasional customer surveys.

3. Vendor & Site Supervision:

Monitor Market to ensure it is running safely and smoothly; build positive relationships with vendors; review each vendor's setup; enforce rules in the Vendors' Handbook and issue infraction tickets for noncompliance; engage in conflict resolution; and collect vendor sales data.

4. Programming & Volunteer Supervision:

Monitor Market [Buskers](#), [Community Booths](#), and Kids Zone; tidy Kids Zone as needed; and direct any volunteers helping with setup and/or teardown.

Skills and Requirements:

- Organization
- Responsibility and initiative
- Positive attitude
- Conflict resolution
- Strong communication skills
- Ability to lift 40 lbs repetitively during Market setup and teardown
- Ability to work outdoors (hot or cold, rain or shine)
- Ability to show up on time and early in the morning
- Use of personal phone to communicate with Operations Manager during Market day
- Use of personal email to communicate with Operations Manager (1-2 emails per week)
- Commitment to the entire (or nearly the entire) Outdoor Farmers' Market Season
- Certified in Standard First Aid and CPR Level C & AED or higher (the OFM would pay for you to obtain this certification if you do not already have it)

Desired Competencies (not mandatory):

- Previous work experience at Farmers' Markets or similar environments
- Bilingual (English and French)
- Passionate about local food and agriculture



Application Process:
